



## CAKE CONTRACT/POLICY

**Down Payment/Deposit-** There is a 30% non-refundable down payment, due at time of reservation. In the event of cancellation, these monies are forfeited and cannot be used toward any future cake purchases. \_\_\_\_Initial

**Final Payment** - Final payment is due on or before \_\_\_\_\_, (7 days before your event). The final count within 50 servings above or below the estimated count is due five (5) before the delivery date, \_\_\_\_\_. After the final payment due date, only CASH will be accepted before 5 PM (the Monday following the final payment date), \_\_\_\_\_, after which, your order will be CANCELED. \_\_\_\_Initial

**Note:** Notification of cancellation must be made no later than 10 calendar days prior to the delivery date. Any cancellations made after this time, will forfeit 80% of total payment which cannot be used toward any future cake purchases. \_\_\_\_Initial

Wedding orders and design consultations must be completed no later than six (6) weeks before the delivery date. Orders placed later may incur additional rush order charges based upon time and product availability.

**Pickup Waiver:** If you have chosen to have your cake picked up, we cannot be responsible for damage to any cake once it has left our facility. Any repairs or additional cakes will be subject to additional fees. \_\_\_\_Initial

**There is a \$25 fee for all returned checks.**

**Cake Stands-** There is an additional deposit for Cake Stands or other hardware. These deposits will be based upon the value of the items being used/rented. These deposits should be made in a separate check, received with the final payment. This check will not be deposited but held in trust and returned when cake stands are returned within 3 days and in good condition. The value and shipping costs of any broken or missing pieces will be deducted from your deposit. Because our sets usually cost more than the deposit, you may be required to pay the difference. In the event you neglect to return our set by the Friday (or 6 days) following the wedding, you will be responsible for the cost of replacement.

**GUARANTEE** - PureKaret promises you the best product and service we can provide. It is always our goal to satisfy our clients. However, PureKaret cannot be held responsible for anything that should happen to the cake once delivery and setup are complete.

**DISCLAIMER** - Direct sunlight and temperatures exceeding 77 degrees may have adverse effects on any decorated cake.
